#### PLAINTIFF'S NOTICE OF APPEAL

Comes now the plaintiff Stewart A. Webb appearing *pro se* and makes the following notice of appeal of the trial court of Hon. Judge Fernando J. Gaitan Jr. "s December 14, 2009 order dismissing the plaintiff"s action:

- 1. Hon. Judge Fernando J. Gaitan Jr. s denial of the plaintiff Rule 59 Motion for New Trial, and the issues raised in the Rule 59 motion including:
- 2. The trial court of Hon. Judge Fernando J. Gaitan Jr. "s denial of the plaintiff"s *in forma pauperis* status in direct violation of the US Supreme Court so overturning of the Tenth Circuit Court of Appeals in *Erickson v. Pardus*, 511 U.S. 9 (2007) on materially the same facts;
- 3. The trial court of Hon. Judge Fernando J. Gaitan Jr. sua sponte dismissal of the plaintiff cause as Hon. Judge Fernando J. Gaitan Jr. had in *David Martin Price v.*
- Kathryn H. Vratil, et al., No. 09-21981 in direct violation of the US Supreme Court in Taylor v. Sturgell where the court specifically held that "...such "nonparty preclusion" runs up against the "deep-rooted historic tradition that everyone should have his own day in court."" Taylor v. Sturgell 553 U.S. \_\_\_\_ (2008).
- 4. The Hon. Judge Fernando J. Gaitan Jr. "s determination of mootness of the plaintiff"s Motion for Summary Judgment and memorandum of controlling law supported by over 80 factual exhibits which cannot be frivolous and entitles the plaintiff to the relief he seeks and was unopposed by the defendants
- 5. The memorandum in support of the plaintiff"s motion for summary judgment specifically gave Hon. Judge Fernando J. Gaitan Jr. evidence of federal felony crimes being committed by State of Kansas officials to violate Civil Rights and injury to similarly situated individuals who were retaliated against through extrinsic fraud over federal court proceedings to meet the burden of proving the 1st and 2nd criteria for injunctive relief under *Kansas Hospital Association v. Whiteman*, 835 F. Supp. 1548, 1551-2 (D.Kan. 1993).

The plaintiff is living below poverty on federal food stamp assistance and the dismissal of his complaint while stated as without prejudice in actuality prevents the plaintiff from obtaining redress and if not overturned is effectively a final judgment on the plaintiff s claims.

1 The *Price v. Judge Vratil et al* case is on appeal before the Tenth Circuit and in

related Habeas Corpus appeals, the State of Kansas Court has interfered with and obstructed justice to prevent David Martin Price from briefing the Tenth Circuit by criminally intercepting David Martin Price's clearly marked legal correspondence from the Shawnee County, Kansas Jail a recorded audio admission of which by the Jail Director is in possession of the Tenth Circuit.
